



This Deed of Public Charitable Trust executed on this 3<sup>rd</sup> day of July, 2018 by Mr. Rajeev Kumar S/o Late Sh. Khagesh Chandra Jha R/o A-102, Apex Green, Valley, Sector-9, Vaishali, Ghaziabad, U.P.-201010 called the "Settler" (which expression shall, unless excluded by or repugnant to the context, be deemed to include his executors, administrators and representatives) of the FIRST PART, and

1. FORMATION:

The 'TRUSTEES' have agreed to become Trustees and to hold and apply the said sums for Public Charitable purposes.



2. **NAME OF THE TRUST:**

The TRUST is hereby constituted as an Irrevocable Trust and it shall more particularly be known as "SHREE KHAGESH CHANDRA JHA CHARITABLE FOUNDATION" The TRUSTEES may change the name of the Trust, after complying all the necessary legal formalities in this regard.

3.(i) **REGISTERED OFFICE:**


Registered office of the Trust shall be situated at 203, 2<sup>nd</sup> Floor, Plot No.2, LSC Pratishtha Sadan, Near KKD Court, Rishabh Vihar, Delhi - 110092 and any such other place as the Trustees may decide from time to time. and Reg. area 100 Sq. ft.

  
(i) **AREA OF OPERATIONS:** All over India

4. **AIMS & OBJECTIVES:**

The objects for which this trust is established are:

- 1) To aware and educate the poor children of the society who cannot afford.
- 2) To establish speech therapy centers, physiotherapy centers, occupational therapy centers, language therapy centers, education, recreational centers, etc. for all including persons with poor, special, handicapped / disabilities and marginalized.
- 3) To establish Primary, Secondary, Higher Secondary Schools, Colleges, training institutions, clinic, hospital, service centre, workshop, vocational rehabilitation center, placement agency, Old age home, Library, reading rooms for general public at large.
- 4) To start/ run/ initiate different courses including degree, diplomas, PG, Doctoral programs of HRD for general public at large.
- 5) To establish, open, develop, run, support, maintain and administer Play School, Schools, colleges, Institute, Hostels, Management Training centers & career counseling centers to provide education of all types (i.e. Basic, Professional, Technical or Non-Technical) also engaging in the activities necessary to education for the benefit and use of the general public at large.
- 6) To give financial aid monthly, yearly or periodical grant to deserving poor students who are studying in any Educational Institutions.
- 7) The trust will strive to provide financial assistance to poor, meritorious students at primary, middle, higher secondary levels as well as college education.



- 8) To establish, acquire, hold, construct, maintain and run group of faculties, universities in different fields, affiliation of Secondary and Senior secondary education, Sports Academy, colleges affiliation, institutes, regular and distance education, diploma for tour management, tour & distance education program, polytechnics for imparting all sorts of education in the fields of medical, Para-medical, engineering, management, vocational courses in India to children, boys, girls, men and women.
- 9) To run project "Education is right of every child" for education upliftment.
- 10) To provide treatment to sick and injured cows. Take special care of cows which are physically weak and handicapped.
- 11) To establish Deemed University, further establish institutions in various academics independently and/or in collaboration with or in joint venture or through tie-ups with other Institutions, Universities, Educational Entities and Governments in India and abroad for furtherance of education and learning.
- 12) To arrange and provide vocational training, skill development, skill gap assessment studies, skill mapping assignments, skill development training schools, Skill updation, and management training for self-employment and legal help to poor and needy Youth, blind, women and children.
- 13) To establish, open, develop, run, support, maintain and administer Skill Development Centers to empower the youth especially women at all level (i.e. Basic, Professional, Technical and Non-Technical) also engaging in the activities necessary for their overall development so as to benefit general public at large.
- 14) To give financial or other assistance in kind by way of studentships, scholarships, stipends, medals, distribution of books, notebooks, cloths, uniforms, or meals for the poor and indigent students and to the persons suffer due to natural calamities at free of cost.
- 15) To arrange and manage the training institutions in Typing, Short Hand, Computer, Fine Art, Crafts, Tailoring, Music, Painting Modeling, Yoga, Physical Education and in the professional training and to promote / preserve Indian culture, Traditions, Arts, Crafts & other pieces of works and popularizing the same. Also to carry on the activities of arranging concerts, exhibitions and shooting cinematography films for the furtherance objects of the Trust for the benefit of women, children and needy person.



- 16) To start, takeover, establish, support, maintain and administer Saksharshala to eradicate illiteracy, Basic Education, Health Care Education, Online Education, Development Education and empowerment Education.
- 17) To establish, open, develop, run, support, maintain, take-over, construct, alter, improve, manage and control Counseling Centers, Yoga Centre and Meditation Point / Meditation Centre, Old-age Home, Naturopathy center, Orphanage Home, Ashram, Dharamshalas, Shelters, Creche, Goshalas, Community centers, Pious, Toilets (Shochalaya), Drinking Water Tank, Career Counseling Centers and other Centers for the benefit and use of the women, children and general public at large.
- 18) To establish, open, develop, run, support, maintain and administer data bank, research center, awareness center, survey center and other similar centre for the benefit of social, cultural and economy development
- 19) To arrange, provide and help for job searching & placement to the benefit of the general public.
- 20) To arrange of the employment awareness camp/programs for the benefit of poor & needy students.
- 21) To establish, acquire, hold, construct, maintain and run group of faculties, universities in different fields, colleges, institute polytechnics for imparting all sorts of education in the fields of medical, Para medical, engineering, management, vocational courses and primary and secondary education in India.
- 22) To engage in the activities for the welfare and empowerment of unprivileged, downtrodden, and helpless Youth, women and children.
- 23) To conduct and to participate in regional, national, and international exhibition, events, seminars, Heritage Walks, culture tours, conferences, workshops on rural, cultural and economy development.
- 24) To provide and arrange information, awareness and training of Human Rights, Right to Information, Violence against women, Women Rights, Child Rights, Fundamental Freedom for Health and Consumer Protection right etc. for the benefit of the Youth, women and children.
- 25) To arrange events, workshops and protest, movements/ aandolan, anti-corruption campaign to safeguard of Human, Women & Child Rights and against of social evils.
- 26) To create awareness of Right to Information (RTI) Act.



- 27) To create awareness for wild life protection, environment & educate the people for preservation of our environment.
- 28) To create a platform for those who wish to work for upliftment of poor and helpless youth
- 29) To Promotion, Upkeep and Conservation of Heritage & Culture at large.
- 30) To work for development of Indian art and folk dances and to provide a platform for those artists who are left behind in terms of recognition and socio-economic development.
- 31) To provide assistance by all possible means to the poor families for the marriage of their daughters, to provide scholarship for the students from poor families.
- 32) To provide financial assistance to the poor families for construction of private/public toilet which shall ultimately be helpful for their dignity as well as preserving the environment.
- 33) To work for physically handicapped for their Skill Development so that they could live an independent life.
- 34) To organize and take up Health, Educational and Welfare programmes for needy Women and children on priority basis.
- 35) To provide help and establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them treatment, medicine, education, foods, counseling, clothing or other help.
- 36) To provide medical, emotional, psychological, social and medical support to senior citizens of our trust by setting up various drop-in centre, senior citizen homes, old-age homes and other entertainment centre so that these highly honorable people should not be neglected.
- 37) To start, takeover, establish, support, maintain and administer Clinics/Hospitals/Nursing homes for the help of poor & needy men, women and children and those who are handicapped or are suffering from infectious disease for the purpose of serving humanity.
- 38) To open and establish charitable veterinary hospitals and clinics in various places for giving treatment to animal and bird and work for their welfare.



- 39) To provide welfare schemes to the aged, destitute, handicapped, orphans and help them to live a meaningful life.
- 40) To arrange and provide medical facilities of any or all types for general public at large.
- 41) To arrange and organize Eye & Blood donation camps and Health Check-up camps.
- 42) To educate people on HIV/AIDS and other such diseases which can be prevented by some precautions. Also to enter into such activities necessary for the objects.
- 43) To carry out all types of health and hygiene programme i.e., vaccination, population control, sanitation, movement, awareness towards AIDS, Malnutrition etc. and related programmes in developing and under developed areas.
- 44) To open centers/ Institutes for diagnostic curative and research of Cancer, Aids, T.B., and other deadly diseases, as per Govt. rules.
- 45) To arrange and provide work for widows, women and children upliftment.
- 46) To arrange programs for women empowerment & Tribal empowerment.
- 47) To start the mobile clinics and ambulance for the benefit of the general public at large.
- 48) To find out the ways and means to eradicate the social evils like atrocities and violence against women and children.
- 49) To arrange and manage marriage programs for needy and poor women / widows.
- 50) To take up effective but reasonable and lawful steps for the eradication of social evils such as Dowry System, Wastage of money in various function, use of intoxicated drugs, Child Marriage (Bal Vivah ) and Child Labour, etc.
- 51) To spread the learning of Vedic scriptures to enhance the performance of one's duties in life.
- 52) To give poor people confidence, hope, dignity and strength and promote principles of Participation, Empowerment and Sustainability.
- 53) To provide and arrange capacity building programs/seminars and legal advice for needy persons.



- 54) To promote, provide work, education and awareness for Clean India (Swachh Bharat Abhiyan), Plant Protection, Environment, Cleanliness, Global warming and new techniques of plantation & other related schemes.
- 55) To provide help to earthquake, Tsunami and any similar accidental situation for victim persons.
- 56) To provide a common platform to NGOs, Societies, Self Help Groups, Co-operatives, Village level committees and artesian for exchange of information and opinion of common interest by organizing Seminars, conferences, training programs.
- 57) To grant relief and assistance to the needy / sick persons and to distribute relief material, medicines, food, water etc. in the places affected from flood, drought, famine and war etc. either independently or jointly with any Government or Semi-Government agencies or Association of similar object, out of its own funds or collected from outside by way of donation, grants, or contribution etc.
- 58) To arrange, propagate and organize camps in rural and urban areas on 'Grow more plants', 'Save Mother Earth', 'Water Conservation', 'Energy Conservation' 'Use Alternative Sources of Energy like Solar Energy', 'Use Bio Diesel', 'Global Warming'.
- 59) To provide and arrange welfare, entertainment, sports and other programs/activities for the benefit of general public.
- 60) To engage in the activities of research and development for the health, education and welfare of the Society.
- 61) To provide work, education and awareness for Plant Protection, Environment, Global warming and new techniques of plantation & other related scheme.
- 62) To acquire and take over all or any part of movable or immovable properties of any similar Trust, society or institution or anyone else whosoever may be for the fulfillment of aims & objects of the Trust and to maintain such assets.
- 63) To receive/give/raise funds, through grants, aid, donations, CSR, subscriptions, sponsorship, presents, rent, gifts and loans or any assistance in other form etc. for the fulfillment of aims & objects of the Trust.



- 64) To manage, purchase or deal with movable and immovable properties for the Trust keeping in the interest of aims and objects of the Trust.
- 65) To work in the area of preservation of natural eco-system, C.N.G., P.N.G., pollution control, bio-diversity conservation, afforestation, environment management, watershed management, reclamation of problematic soil and alternative energy programmes.
- 66) To receive financial and non-financial assistance from any Government and Non-Government organizations, International agencies/ organization, Banks and other legal entities or individuals, as permitted by rules of the Government of India.
- 67) The Trust is a charitable, Non-Religious, Non-Political & Non- Government Social Welfare Organization registered under the Indian Trust Act, 1882 and to carry out the objectives of Welfare, Charitable, Social & Humanitarian Services for Indian citizen public at large without any discrimination of colorcast creed religion etc.,
- 68) To invest funds and help investment of any funds in the modes of investments from time to time which is in terms of Income Tax Act, 1961 or any other law for the time being in force and subsequent amendments thereof from time to time.
- 69) All the activities of the Trust shall be non-profitable and shall be conducted on "No Profit - No loss basis".
- 70) The objects of the Trust are for charitable purpose without distinction of cast, creed, colour or sex (gender) and as per rules regulations of the Government of India.

**The Ancillary Objects of the Trust, in furtherance and Promotion of the aforesaid main objectives are:**

All the incomes, earnings, movable, immovable properties of the Trust shall be solely utilized and applied towards the promotion of its aims and objectives only as set forth in the objectives and no profit thereof shall be paid or transferred directly or indirectly by way of dividend, bonus, profits or in any manner whatsoever to the present or past Trustees of the Trust or to any other person claiming through anyone or more of the present or past Trustees. No Trustees of the Trust shall have any personal claim or any movable or immovable properties of the Trust or make any profits, whatsoever by virtue of his/her Trusteeship.



RULES AND REGULATIONS  
OF  
SHREE KHAGESH CHANDRA JHA CHARITABLE FOUNDATION

**1. TRUSTEES OF THE TRUST:**

Any person (more than 18 years)/Firm Company / organization / NGO / Cooperative/Samiti/Federation of India or from other country whose names appear in these rules and regulations as the first Trustees of the Trust and the persons who are subsequently admitted as Trustees by the managing committee in accordance with the rules of regulation of the Trust deed.

**a. General Trustee:**

The General Members/trustees will have all rights of management committee.

**b. Associate Trustee**

Any person (more than 18 years)/Firm Company / organization / NGO / Cooperative/Samiti/Federation of India origin or origin of any other country who can opt for this membership on payment of annual fees. They are providing services from time to time and these Trustees will have no Trusteeship of management committee and they do not have any voting right.

**c. Patron**

The patron trustees as a Hon'ble advisory Member of the Trust and any intellectuals after consideration of Managing committee can become a Hon'ble Patron Members of Trust. The Patron members do not have voting rights.

**2. SUBSCRIPTION:**

- (a) **A non-refundable admission fees** of Rs.500/- (Rupees Five Hundred Only) at the time of admission.
- (b) **Annual non-refundable Subscription:** Annual non-refundable subscription shall be minimum Rs.1000/- (Rupees One Thousand only) per annum and the Managing Committee shall decide the amount of the subscription at the close of each financial year.
- (c) **Life Trusteeship fees:** One Time non-refundable fees of Rs. 5100/- (Rupees Five Thousand One Hundred Only) to be paid at the time of enrolment and the \*Management Committee shall revise the amount from time to time.



3. MANAGING COMMITTEE OF THE TRUST:

- i. Mrs. Mankamna Devi - President
- ii. Mr. Rajeev Kumar - General Secretary
- iii. Mrs. Babita Jha - Treasurer

4. POWER AND DUTIES OF THE TRUSTEES:

i. President

- a) He/She shall supervise all works and activities of the Trust and the other office bearers.
- b) He/She shall be head of the Trust and preside over the meetings of the Managing Committee. He/She shall have the right of the casting vote.
- c) To sign on behalf of the Trust, any document/deeds and do all the correspondence with the registrar office/concerned departments/persons and participate in meetings on behalf of the Trust.

ii. GENERAL SECRETARY

- a) To sign on behalf of the Trust, conduct its correspondence and record its proceedings of the meetings with concurrence of President.
- b) To summon the General meeting with the consent of the President or at his/her instance with absence.
- c) To call Ordinary General Body Meeting if so desired in writing by at least 2/3<sup>rd</sup> Trustees of the Committee.
- d) To remove/terminate any or all the staff/executives/consultants/Director/ Manager/ Chief Coordinator etc. if found not working in the interest of the trust.
- e) To undertake all such other functions as may be Managing Committee from time to time.
- f) The Director, Manager / Staff/ Chief Coordinator and all other executives shall be appointed by the President of trust in concurrence with the board of trustees to handle the objectives of the trust or institution of the trust to the best in all respects.

iii. Treasurer

- a) He/She shall keep accounts of receipts and expenditure of the Trust and furnish annual accounts to the Managing Committee.
- b) To undertake any such other activity as may be assigned to him/her by the President /Managing Committee from time to time.



**5. TRUSTEES:**

- i. The first trustees are appointed for life, but will be at liberty to resign on giving one month's notice of his/her intention to do so and they will be the constitutes Managing Trustees.
- ii. The President shall have all the powers as are vested in the Board of Trustees, except those which are specifically to be exercised as per law only by the board and cannot be delegated.His/her duty is to keep the board informed of the same.

**6. TERMINATION OF TRUSTEESHIP:**

The Trusteeship of any Trustee shall cease to hold his/her office if

- i. A no confidence motion is passed by 2/3<sup>rd</sup> majority of votes in the Managing Trustees Meeting.
- ii. On his/her written resignation.
- iii. on his/her death.
- iv. on his failure not to attend without any plausible reason consecutive meetings of the General Body without any intimation /leave of absence.
- v. for any other violent, unsociable, unbecoming behavior etc.
- vi. A Trustee who wishes to resign shall have to submit one-month notice before tendering his resignation.

The reason of termination from Trusteeship shall be communicated to the Trustee concerned in writing.

**7. MEETINGS OF BOARD OF TRUSTEES:**

- i. The Board of trustees shall meet as often as may be necessary or convened to transact business. The Board of trustees is empowered to transact business and take decisions also by circulation of paper.
- ii. All decision of the Board of Trustees shall be taken either unanimously or by majority and if the Board is equally divided, President will have the casting vote.
- iii. The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulation:-
  - (a) All matters will be decided mutually by the Trustees.
  - (b) Resolution passed without any meeting of the Trustees but by circulation thereof and evidence in writing under the hands of 2/3 two thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.

8. **AMENDMENTS IN THE TRUST DEED:**

The trustees are authorized to add/amend any clause of the trust deed including the aims and objectives of the Trust.

9. **ACCOUNTS & FINANCE:**

- i. The accounting year of the Trust shall be the financial year ending on 31<sup>st</sup> March every year.
- ii. The Trust and the Trust funds shall be irrevocable for all times.
- iii. The accounts of the Trust shall be audited at least once in a year by a qualified firm of Chartered Accountant appointed by the Management Committee.

10. **SOURCES OF INCOME:**

- i. Registration, Admission, special or any other fee in any mode.
- ii. Subscription, Sponsorships and Interest by way of any mode.
- iii. Donation, gifts, CSR, presents & special contribution of any nature.
- iv. Grants, aid, loan or any other assistance.
- v. Receipts from Investment of the Trust Fund & Rent.
- vi. Any other receipt not covered by article 10 (i) to 10 (v).

The Income of the Trust received from India and Outside India as may be from all sources will be utilized for the attainment of the aims and objectives of the Trust.

11. **REMUNERATION TO THE TRUSTEES:**

The Trustees will not be entitled for any remuneration. But they shall however be entitled to reimburse themselves expenses incurred by them in the course of discharging the professional services/functions for the Trust. Further income and fund of the Trust will be solely utilized towards the objects and no portion of it will be utilized for payment of Trustees by way of profits, interest, dividend or otherwise. If any trustee, other than the settler, shall be a Professional like-lawyer, doctor, accountant, consultant, teacher etc. he or his firm shall be entitled to charge for his or their services.

12. **MEETING OF THE TRUSTEES:**

- i. The trustees shall hold the Annual General Meeting of the trustees once every year at such time (not being more than 15 months after the last preceding Annual General Body Meeting) and at such place as may be prescribed by the President of the trust. In case of any dispute, the decision of the President shall be final and binding upon all.
- ii. A minimum of ten clear days' notice shall be given of every Annual General Meeting to every trustee containing the Agenda for the meeting.

iii All other minutes of the Board of Trustees shall be sent under postal certificate and shall be deemed to have been served if addressed to the Trustees at the address given for the purpose.

**13. DISSOLUTION:**

The Trust will be dissolved as per the provisions laid down under trust Act, as applicable to the National Territory of Delhi. If upon dissolution of the Trust there shall remain after the settlement of its debts and the liabilities any property whatsoever, the same shall not be paid to or distributed among the Trustee of the Trust but shall be given over to same other trust/society/organization with similar objective according to the decisions of the Trustee or, in default thereof, according to the decision of the competent court.

**14. BANK ACCOUNT:**

- i. The fund of the Trust shall be kept in a Scheduled Bank or any other bank as trustees deem to be fit. With a view to generate income for the trust and best utilization of trust fund, the funds shall be invested in FD, CDs of scheduled banks, units of UTI, Mutual Funds, Bonds/Debentures of any Indian Financial Institution, Government Securities or any other securities or schemes as deemed fit and as permitted by law for the time being in force, considering the overall benefit of trust.
- ii. The money shall be authorized to be withdrawn by the General Secretary jointly with President or Treasurer of the Trust.

**15. APPLICATION OF FUNDS:**


It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly, as permitted by rules of the Government of India.
